

# **Event Data Disclosure Agreement**

# I. Acceptance of Terms

NASCIO provides this conference for the purpose of member education and networking.

It is important that you read all terms and conditions carefully as by registering for, attending, and/or utilizing event services, you agree to the collection, use, and sharing of your personal data for the purpose of your participation in this event.

#### II. Collection of Data

### Registration

By registering for this event, you are providing to NASCIO personal information such as name, organization, job title, address, email, phone and dietary needs. The collection of this information is to provide you with services as it relates to your attendance at this event. Without this information, NASCIO will be unable to guarantee the provision of said services.

By registering, you agree and acknowledge that you are over 18 years of age. If you are under 18 years of age, please contact NASCIO directly at registrations@NASCIO.org.

You agree that the information you provide during the registration process is accurate, true, and complete. You have the right and responsibility to update any incorrect or out of date information in a timely manner. Provision of erroneous information may result in the failure to receive important updates and information about the event. You may update your registration by contacting NASCIO at registrations@nascio.org.

By registering, you also agree that NASCIO may use information collected during the registration process to notify you with information about NASCIO and/or the event such as: reminders, updates, logistical changes in the event, and post-event satisfaction data collection.

NASCIO uses Cvent's Attendee Hub in the facilitation of this event. By downloading and utilizing Attendee Hub the participant agrees to the terms and conditions of the application independently of this agreement and is solely responsible for all personal information provided and shared through the application.

## **Payments**

Electronic payment for event registration is taken and managed in Cvent. Sponsorship payment is taken via MemberClicks and processed by Payscape. Any optional Give Back donations made outside of the registration process are taken by Donor Box and processed by Stripe. Give Back donations made during registration are handled the same as event registration payments detailed above.

#### Attendance

During the event, it may be necessary for attendees to verify their personal information provided during registration as it relates to event attendance. This personal information is for the sole purpose of verification of previously collected data to confirm your identity, accommodations, and delivery of services at the event. Failure to provide this information during attendance may result in the inability to render services to the attendee.

Additionally, this event provides opportunities for networking with other attendees. Personal information shared during networking is the sole responsibility of the attendee. Attendees should exercise sound judgement concerning sharing of personal information with others and should take necessary steps to ensure privacy and protection of said information as NASCIO shall not be responsible for information shared in this capacity during the event.

#### III. Data Use

## **IV. Data Sharing**

fulfillment of these services and understand that NASCIO will require that all third-party suppliers abide by these terms in their fulfillment of said services.

## Legal Disclosures

NASCIO, our suppliers, and or partners do not share or sell your personal data with third parties for their direct marketing purposes without your permission.

### V. Data Storage

You agree that NASCIO will retain the personal information provided and maintain accurate records of this event in addition to the provision of services. All data is retained and stored in perpetuity for historic record of this event. You have the right to request that your personal information be deleted or a portion thereof; however, NASCIO will retain information which is reasonably necessary to meet accreditation standards, meet regulatory requirements, resolve disputes, maintain security, prevent fraud or abuse, or enforce this agreement.
