SCMS - Disrupting contract management across government

The Strategic Contract Management System (SCMS) is effective, consistent, and nimble P3 contract management and oversight designed for government. This first of its kind, low-code, scalable application has been developed to enhance user performance and management oversight.

SCMS ensures the Right People are doing the Right Things at the Right Time.

Now more than ever, Government demands consistent approaches across contract managers while simultaneously delivering users and managers flexibility and customization. SCMS is built from the ground-up to deliver on these competing goals through enhanced communication, intuitive user experience, and complete data transparency.

Designed with an eye toward the future

SCMS was built leveraging a low code solution through Microsoft. The low code design facilitates and simplifies the handoff from the design team to your IT departments, making it easy for your team to pick up the application and manage it in perpetuity. And because the application is low code, it gives a high degree of autonomy over application updates to the users and project team, decreasing the oversight burden on IT departments. The application's low code development contributes toward its future proof design supporting your ability to leverage the application to manage contracts decades into the future. SCMS is Section 508 compliant and built to the same standards leveraged by the U.S. Department of Defense.

Out with the old...

SCMS was conceived by the Virginia Department of Transportation (VDOT) Office of P3 to answer the challenges of a complex and growing portfolio of contracts. Like many State agencies and offices across the Commonwealth of Virginia, the Office of P3 spent years struggling with inefficient contract management practices. These include:

- · Inconsistent application of agreements
- Undefined contract roles
- Decentralized data and document storage
- · Inefficient management of a growing portfolio
- · Weak coordination between Central and District Offices

Business as usual was creating significant risks for VDOT's P3 contracts and the need for an innovative contract management solution was identified. When a sufficient, cost-effective solution could not be found the team decided to build a solution from the ground-up. The result: **The Strategic Contract Management System** – the industry's first cost effective, scalable P3 contract management system.


Intuitive and customizable interface

Seamless management across tasks

Effectively coordinating and documenting approvals across contract tasks is critical for responsible and ethical contract management in Government. But too often Government contract managers are not given the appropriate tools and resources to properly execute on time. In many instances Government project managers are forced to manage contracts through self-made excel sheets, email, and verbal agreements. This creates additional work and burden for project managers as well as threats for the organization such as lack of transparency, over reliance on institutional memory, and too much lost expertise with employee turnover.

SCMS creates and records the chain of actions related to each individual contract task <u>in one</u> <u>centralized location</u>. This approach streamlines actions to ensure all relevant parties are engaged and creates a historical record with each action that can be leveraged by project managers decades into the future.

Comprehensive Business Intelligence

Business Intelligence dashboards allow for high level, comprehensive oversight for all tasks and activities related to contracts. Dashboards are tailored to the individual needs of users from local offices up to central office and executive level.

Users have the option to view status of activities across the entirety of the Commonwealth, or drill down into District specific priorities. The SCMS project team is continuously engaging with users across all levels to maximize the value of dashboards.

BI Dashboards remove the guess work from executive level oversight while providing full user transparency across the system, even at the District level.

In 2022 SCMS was awarded State IT Innovation of the Year for excellence in State Government technology by StateScoop 50. Millions of votes were cast in this competition and SCMS was selected for SCMS's "game changing" approach to contract management and scalability across VDOT and State Agencies across the country.

In addition to the StateScoop 50 award, SCMS continues to be nominated for technological excellence and innovations in competitions across Virginia and throughout the country, from the VDOT Chairman's Award to the P3 Awards. Further, the Team is regularly fielding requests from throughout Virginia, across the United States, and with international partners to demonstrate this technology for broader implementation.

The Virginia Department of Transportation's new strategic contract management system has been "a game changer," says Brian Kontur, program manager for the department's Office of Public-Private Partnerships. "It's intuitive for users," Kontur says. "These contracts and these roles that VDOT is working with on the contracts, they can be dozens of years old, so as people come and go, that can be a pain point in handing off that information." He says the new system also uses low-code technology, making it easier for the commonwealth to maintain long-term.

"We knew that there was no value to a contract management system that was not future proof. P3 contracts can run as long as a century and we needed a system that was going to be with us for the long haul.
